



ADDENDUM TO PLATINUM MEMBERSHIP AGREEMENT

Here is the Pickles and Play Platinum Off-Hour, Non-Staffed Access Policy and Responsibility Waiver:

- 1) Your personal access code **must not** be shared with anyone
- 2) You can access the facility as early as 5:45am for 6am reservations and stay until midnight. The last member in the facility is responsible for turning out the lights at the end of the night
- 3) You are responsible for all other players behavior on your court
- 4) One platinum required to be on the court reservation during off hours.
- 5) You CANNOT leave other members in the facility if you leave. All of your respective members and guests on your court must depart if you do
- 6) Do not bring in a player whose membership is knowingly expired or canceled
- 7) Cameras will be checked daily
- 8) Only go behind the desk to get concessions and write them on the concessions sheet if staff is not present
- 9) You will not have the ability to purchase merchandise from the pro shop
- 10) If you use the ball machine, you are responsible for bringing balls as staff will not be on site. Erne must be put back up front and plugged in. Platinum members may also bring their own personal ball machine.
- 11) Absolutely no coaches allowed to give lessons, paid or unpaid. Whether or not you receive compensation for it, you may not teach private or group lessons in our centers or on our courts.
No organized sessions or outside any P&P league use play or any other activities unless facilitated by a P&P employee. You may not organize your own informal or formal sports leagues, tournaments, or programs. We employ our own Team Members and online tools to facilitate all programs at our venues. You may connect with PnP management about any program you desire for approval.
 - PnP retains sole discretion to determine whether a member or guest is engaged in organizing or participating in non-Pickles and Play activities.
- 12) All non-members and guests MUST be registered on the court reservation and must be paid for through CR if attending a session during off hours. If you need adjustments to the reservation or want to use guest passes, you can email Leesa@picklesandplay.com for those requests.
- 13) You must still book courts during platinum hours to ensure appropriate court utilization
- 14) Our staff will clean the facility at the end of their evening shift so please be respectful of the facility and clean up after yourself for any members coming in the following morning.
- 15) Any injuries while staff is not present is the responsibility of the player. P&P is not liable for any incident (first aid kit available on top of AED). There is also club information posted near the AED to assist if a player needs any outside assistance from medical personnel.

Violation of the policy can lead to membership suspension or cancellation. The decision is at the discretion of the Pickles and Play staff and management/ownership. All platinum members when they become platinum are automatically subject to these requirements agreed upon in CourtReserve.
